THE POWER OF THE HEBREW WORD

This article was written in 2006, but it is still very relevant.

In 2001 a fascinating book that should have made an impression on the Western world historians and the public in general was published. But it did not happen. The author is Benjamin Blech, and he is Jewish rabbi and professor of Talmudic studies at the Yeshiva University in New York. The book's title is "The secret of the Hebrew words" and in it the academic professor shows a number of examples of the relationship between the Hebrew language, as the Torah texts written in, and the Jewish theology and understanding of history. The book is written for orthodox Jews, but others can also read it to get a better understanding of the relationship between Hebrew numerical mysticism and the Jewish religion. For Jews, the Hebrew language is sacred and each character corresponds to a number. That means that many Jews believe, that you can deduce prophetic predictions of the Old Testament, that the Jews calls the Torah. They believe that God himself has written the Old Testament texts and that he has coded them full of secrets so that people in the future can use their time on to interpret the world and the times to come.

Most Christian theologians see this as number magic and as superstition, but others take it seriously. Best known in this context is probably Jehovah's Witnesses and various Adventist sects, which have repeatedly predicted the end of the world from such textual passages and the numeric analysis of these. So far, this has proven not to be true.

When Benjamin Blech's book is so interesting is because it ends with a review of the Old Testament (Leviticus 25:10), where you can read:

"And ye shall hallow the fiftieth year, and proclaim liberty throughout the land to all its inhabitants."

The interesting aspect of this verse is, says Benjamin Blech, that it predicts Israel's formation and the number of victims at the Nazi Holocaust. The rabbi shows that the Hebrew word for "we shall come back" is misspelled in the original text. One letter is missing, namely what corresponds to the Latin "v" which in Hebrew numerical code is identical to the number 6. The absence of this letter show – according to Benjamin Blech - that even the writers of the Old Testament 2500 years ago was aware, that 6 million Jews should pass away before the Jewish state could be restored. Blech also believe that the founding of Israel in 1948 is predicted in the same text passage.

It all fits perfectly. The precondition for Israel's creation was the fate of the Jews during World War 2, and in countless Hollywood movies and television-shows we have learned that it all actually happened as the holy book predicted 2500 years ago. There were 6 million Jews who died as a result of Hitler's campaign and since a famous Hollywood production called "Shoah" was shown on television in the Western countries 1965, this has been called the "Holocaust". The prophecy that the Jews believed in for 2500 years came true, and Hitler was really just a tool for the advancement of the heavenly idea of creating a Jewish state: Israel.

Taking into account that the original Hebrew of the Old Testament is written over two thousand years ago, it is rather remarkable that it has predicted the number of Jews

killed during World War 2, and the most notable is it that a number of alleged Jewish scientific writers have come to the same numbers through what, they claim, has been a thorough a scientific study of the statistical information available from the war time.

The former chairman of the Mosaic Religious Community in Denmark - Jacques Blum – used a lot of pages in his last book against the Holocaust-deniers to prove that the figure 6 million is still absolutely true, even if the number of Jews killed at Auschwitz for some years ago was written down from 4 million to 1.5 million. This reduction of the killing-rate with 2.5 million should lead the researchers to reduce the total number of dead from Holocaust from 6 million to 4.5 million, but it did not happen. Blum and the other Jewish so called “researchers” discovered at the same time - all by coincidence - that there were 1.5 million deaths, which one previously had forgotten to reckon with. The number 6 million was therefore still absolutely true, and the 2,500 years old prophecy was reconciled - thankfully - accordingly to modern research. The authors of the 2500 years old Testament was right. Once again myths did overshadow documented facts in the Jewish version of history.

There is a prophetic power in the Hebrew word. It is said that the founder of Zionism Theodor Hertzl wrote in his diaries of the late 1800s that 6 million Jews would die so the Jewish state could be restored. I have not been able to check this information, as these diaries are unavailable to the public. But reading the Encyclopedia Britannica, 1902, it is stated in the article about "Anti-Semitism" that in Russia there are "*six millions of Jews who are being systematically degraded*" (page 482). Here we see, then, that the old prophecy has already been fulfilled. And the same thing happened immediately after the First World War, when New York's Jewish mayor Martin H. Glynn writes in "The American Hebrew" (31th October 1919), that the war has led to “6 million men and women are dying in the threatened Holocaust”. The same equivalent information can also be found in a number of other Jewish and non-Jewish, filo Semitic, publications published before the start of the Second World War.

Thus, there is not only one Holocaust, but three. Everything is foretold in the Old Testament and each time 6 million Jews have been slaughtered. The first went on in Russia in the late 1800s, the second time in First World War and the third time under the Hitler regime. Three times God's chosen people allegedly have had to suffer so the Hebrew prophecy could come true and so that the Jews could get their own state. 6 mill multiplied with 3 is 18 million, and the total number of Jews in the world around 1900 was about 11 million (Wikipedia), so even the dead Jews have been killed again. Well, everything is possible when we talk about mythology. This is not lying, it is Jewish mythological history.

Personally, I don't quite understand the Jewish God. Does it have to be necessary to kill 6 million of his chosen children to make a new country? Could he not have chosen another way? According to statistics there was only 11 million Jews in the whole world, but never the less the Jewish God killed 18 million. (3 x 6). I think he is very evil. To me he is not I real god but more of a living Satan!

At the same time, we must of course compliment Jacque Blum and the other pseudo-scientists who through a lot of hard scientific falsification has concluded that exactly 6 million people died during the Holocaust. I am amazed how this figure is consistent with the old prophecy. Yes, the Old Testament is truly a divine book. It is full of mystery and divine predictions. And modern Jewish pseudo-scientists is still willing to

do the job of producing false proves that the old predictions are true. Myth, fantasy and reality is one and the same for these people.

My own view is that Jehovah must have a moral problem. Why is it necessary to let millions of people die to make a prophecy come true? And why should historical figures as Adolf Hitler be liable for the event, which the omnipotent Jewish God has decided to happen for thousands of years ago?

I find it hard to understand. How can we have something called "Holocaust survivors" when even more than the global population of Jews in the last century was killed? Jewish mythology is a powerful resource. I understand there is a reason why it is forbidden in Germany and other European countries to ask questions like the one I ask here. Freedom of speech is not very popular among the European filo Semites.
